Since 2021, the Green Tech Legal Collaborative (GTLC) has provided essential pro bono legal and compliance support to early-stage green tech startups from Imperial and the Undaunted programme. Founded by Bloomberg and Imperial Enterprise Lab, GTLC has facilitated over £6 million in free legal assistance, helping founders navigate the legal complexities of scaling sustainable solutions.

The programme is supported by Bloomberg and 11 leading law firms, including Ropes & Gray, Willkie Farr & Gallagher, A&O Shearman, Ashurst, Freshfields, Keystone Law, Mayer Brown, Taylor Wessing, Travers Smith, Venner Shipley, and Withers & Rogers. Through this collaborative model, GTLC empowers startups to address climate challenges with confidence.

#### **Addressing the Legal Gap for Green Innovators**

For early-stage climate innovators, navigating legal and regulatory landscapes can be daunting. The high cost of legal services often prevents founders from accessing the support

they need to grow. GTLC bridges this gap by offering expert legal guidance, allowing startups to focus on their mission of driving sustainable innovation.

GTLC is led by a Steering Group consisting of co-founders Mia Motiee, Legal Counsel at Bloomberg LP, and Victoria Nicholl, Head of Incubation Services at Imperial Enterprise Lab, alongside Felicity Kirk, Pro Bono Counsel at Ropes & Gray, and Yannis Yuen, Litigation Associate at Willkie Farr & Gallagher. The Steering Group is supported by Sara Roberts at Imperial Enterprise Lab, and Nicky Trimble at Ropes & Gray, who both play a key role in helping GTLC go from strength to strength.



## The GTLC Journey: Five Years of Growth

#### 2021

Launched by Imperial Enterprise Lab & Bloomberg with founding firms Ropes & Gray and Willkie Farr & Gallagher. Cohort 1 supports 6 startups.

2022

Cohort 2 expands to 10 startups.

#### 2023

Cohort 3 welcomes 18 startups. GTLC wins LawWorks Most Effective Pro Bono Partnership award.

#### 2024

Cohort 4 supports 20 startups. GTLC wins Legal Business Awards ESG Programme of the Year and partners with qLegal for Project Janus Green.

#### 2025

GTLC expands to 11 law firms. Cohort 5 launches in May.

#### **Resting Reef Transforms Memorials into Living Reefs**



**Resting Reef is** reimagining death care with meaningful and sustainable memorials.

Instead of traditional urns or burials, the ashes of loved ones or beloved pets are transformed into living reefs that help restore marine ecosystems, creating a lasting and environmentally friendly tribute. Founded by Aura Murillo Perez and Louise Lenborg Skajem, the company has launched over 20 pilot reefs in Bali, attracting 59 fish species

and enhancing biodiversity.

Recognised on the Forbes 30 Under 30 Europe list for Social Impact, Aura and the team have secured nearly £400,000 in grants, including the Global Explorers Award.

GTLC has been instrumental in Resting Reef's growth, providing legal guidance on incorporation, SEIS/ EIS frameworks, contracts, NDAs, and regulatory compliance. This support has ensured the business operates on a strong legal foundation, enabling it to expand its positive impact on marine environments.

#### **BlueNose Wins Terra Carta Prize for Shipping Innovation**



BlueNose is enhancing containership energy efficiency with aerodynamic retrofits, reducing fuel consumption by up to 5%. Using advanced algorithms, they optimise airflow to cut emissions and costs. BlueNose won the prestigious Terra
